

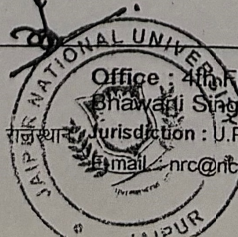

- The institution shall ensure that the required number of academic staff for conducting the courses are always in position.
- The Norms of staff/ qualifications/administrative and professional staff/terms and conditions of service etc. shall be as per the provisions of NCTE Regulations, 2014.




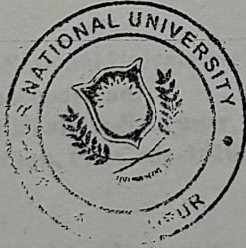


