MEMORANDUM OF UNDERSTANDING

This MEMORANDUM OF UNDERSTANDING (MOU) made and entered into on this ------day of, November 2018, by and between following parties:

- A Factor National Loss costs, Jaipur which expression shall mean and include its successors in interest and assigns of the first part (hereinafter referred to as JNU), AND
- B. Frankling its registered address at Davar Campus, Tansen Road Industrial Estate Gwalior, 474002, with DSIR recognized & D. laboratories which expression shall mean and include its successors in interest and assigns of the second part (hereinafter referred to as (TFPL)

WHEREAS INU and TPPL are interested in entering into a MOU with a view of sharing a common desire to explore, extend and strengthen the functional relationship between the Academic Institution and Industry, in order to share the common interest of serving the Society herewith, sign this MOU on following broad understanding:

- The TROPILITE FOODS Pvt. Ltd. and Jaipur National. University, Jaipur support each
 other in promoting R&D of novel food formulations, analyses, functional validation etc.
- The faculty of Jaipur National University would assist in functional studies and field evaluation of specified food products/formulations developed by TFPL.
- 3. The JNU will provide expertise, specialized laboratory facilities and equipment support available at University and/or any other division for scientific analyses of specified products of TPPL for which due expertise and facilities are available at JNU, Jainur
- 4. The TIPL will support JNU in developing prototype pilot scale food formulations generated out of JNU's in house R&D and Vice versa.
- JNU & TEPL may consider initiative on setting up of Food Quality control laboratories under Public-Private-Partnership mode, for mutual benefit and for the benefit of public in general. A separate agreement in this regard, may be worked out as per the demand, if required so.
- 6. The JNU may consider recognition of DSIR recognized R&D of TFPL as a Research centre of JNU on the recommendation of a committee duly constituted by Hon blc Vice Chancellor.
 - 7. Upon recognition by Jaipur National University, Jaipur research scholars/scientific staff working at R&D of TFPL may register for Ph.D degree to be awarded by Jaipur National University, Jaipur (not exceeding two Ph.D registrations per academic year) provided the candidates passes the Ph.D admission test and successfully completes Ph.D Course work conducted by the University.

- 8. The Scientists/Director working at the TFPL may be considered for recognition as independent Ph,D supervisors. The Ph,D thesis supervisor will be of the level of Assistant Professor or above provided he/she fulfills the qualifications to become a research supervisor as per the Ph,D Ordinance of Jaipur National University, Jaipur.
- 9. The TFPI would permit PG and/or Ph.D students Food Technology, Microbiology, Biochemistry and Biotechnology divisions of JNU for short or long term training in R&D or factory for periods ranging between 2-12 months duration. The number and branch of students for such training/dissertation may vary from year to year and would mutually be worked out between the two organizations. The minimum number students in a given academic year will not be less than ten in any case. No fee would be charged by TFPL either from PG or Ph.D students. (The scientist and faculty member duly authorized by Chairperson or TFPL and Vice Chancellor of JNU respectively would be responsible for finalizing the number and/or modalities in a given academic year).
- 10. Ph. D students working at Jaipur National University, Jaipur will be allowed to avail the R&D facilities and pilot scale facilities available at TFPL and the Organization will extend all necessary facilities, consumables & expertise to the research students.
- 1) The scientists working at R&D of TFPL may supervise/mentor PG students in house protects of Centre for Food Processing, Jaipur National University, Jaipur.
- 12 The scientists of TFPL may take part in teaching program of Jaipur National University, Jaipur in every academic year as worked out by both the Institutions, Lectures may be delivered in Scientist's area(s) of specializations for the benefit of students. The topics of fectures and days/time will be fixed by mutual consultation between the Scientist and Head of concerned Department of Jaipur National University. The Jaipur National University may pay honorarium for the lectures delivered by scientists of TFPL as per the rules of the University.
- 13. The JNC and TFPL may apply for collaborative research projects to external funding agencies such as Ministry of Food Processing/ AYUSH/ DBT under programs such as SIBRL BIRAP or any other such schemes of National or International Organizations and work in close association for achievement of the targets set forth.
- 14. Data generated through collaborative research will be published/ patented by both the Organizations. The Intellectual Property Right shall be jointly shared by Jaipur National University, Jaipur and TROPILITE FOODS Pvt. Ltd., Gwalior.
- TFPL would assist JNU in entrepreneurship based initiatives in Food Processing for the benefit of students.
- 16. TEPL may consider contributing infrastructure requirement for food based R & D at happer National University.
