## ORDER

Whereas Jaipur National University Institute of Medical Sciences and Research Center, Jaipur has filed a Writ Petition No. 10103 of 2018 in the Hon'ble High Court of Rajasthan, Bench at Jaipur praying among other things for setting aside and quashing the Order dated 01.05.2018 issued by the Ministry of Health and Family Welfare. It was also prayed to direct the Ministry to issue appropriate orders granting Letter of Permission for admission of 150 MBBS seats in the 3<sup>rd</sup> Batch (2<sup>nd</sup> Renewal) for the academic year 2018-19 to the Petitioner College;

- Admissions made in violation of the above conditions will be treated as irregular ii. and shall be liable for action under IMC Act, 1956 & Regulations made thereunder.
- The aforesaid permission shall be subject to further orders to be passed by iii. Hon'ble High Court of Rajasthan in this Writ Petition.
- If ultimately the petitioner fails in this petition, he will refund all the fees to the iv. students who are admitted pursuant to the order of the court.
- The Institute/college shall make it clear to the students, who are admitted, that ٧. their admission is subject to the result of this writ petition and SLP, if any, filed by MCI.
