Specific details regarding financial, technical, operational and administrative issues that arise out of the MoU will be taken up later on mutual consent once the possibility of joint collaboration becomes feasible.

Confidentiality

It is agreed and understood that data, know-how and other such proprietary information that was provided or will be provided by either party, will remain confidential.

Governing Law and Settlement of Disputes

1. The present Memorandum will be constructed in accordance with general principles of Law of India.
2. In the event of a dispute, controversy or claim arising out of or relating to this Memorandum or to any agreement(s) concluded pursuant to this Memorandum, the parties will use their best efforts to promptly settle such dispute through direct negotiation. In the event the dispute is not amicably settled, the same shall be referred to Arbitration and for the said purpose the venue and jurisdiction shall be Delhi alone.

Any matter not covered specifically in this agreement may be settled by mutual discussions and addendum to the agreement in writing thereupon.



Final provisions and Duration

1. This Memorandum will take effect upon its signature by the authorized representatives of the Parties.
2. This Memorandum is concluded for an initial period of ten years as the date of signature by the parties, and it may be renewed, following mutual consultation, by exchange of letters for a five-year period or such other period as the parties may decide.
3. Both parties will nominate its nodal officers for an easy and smooth implementation of MoU.
4. This Memorandum may only be changed, modified and amended or supplemented by written agreement of the parties.
5. The Legal relations established by this agreement shall terminate with the end of the completion date of the MoU.
6. Any party wanting to terminate this MoU shall give 90 days' notice in writing to other parties. In the event of the Termination, all the parties have to discharge their obligations under this MoU.
